



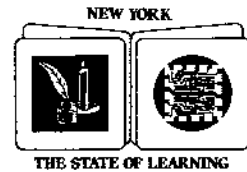
I need not tell you that you were great with our students, who can be a tough audience. You captured and held them from the moment you took the stage.


